## Convene

Presiding Commissioner John Grubaugh called the meeting of the County Commission to order at 9:00 a.m. on July 10, 2008 at the County Commission Office. Attendance: John Grubaugh, Present: Bill Barnett, Present: Tom Huff, Present. County Clerk, Kay Brown, taking the minutes.

## 9:00 a.m. Jim Bresee, Resource Management Administrator RE: Storm Water Agreement Signing

Those present for the meeting were Todd and Bob Ashley from Planning and Zoning Department.

The Commission met with Jim Bresee to review and sign the Storm Water Cooperative Agreement with the cities of Nixa, Ozark, Springfield, Battlefield, Republic and Greene County. Mr. Bresee stated that about six months ago the state created an unfunded mandate that will require cities and counties to have a storm water monitoring plan. Mr. Bresee called on independent companies that provide storm water testing but it was very costly. This cooperative agreement also includes a professional services contract with Missouri State University for a five year period beginning August 1, 2008 through July 31, 2013, for a maximum amount of \$ 30,000.00 to provide the storm water monitoring through Ozarks Environmental and Water Resources Institute (OEWR). A \$ 6,000 payment will be paid annually to be invoiced at \$ 1,500.00 quarterly.

A professional services contract with Missouri State University is attached to the Cooperative Agreement and was also signed by Presiding Commissioner, John Grubaugh, Western Commissioner, William Barnett, Eastern Commissioner, Tom Huff, Attested to by, County Clerk, Kay Brown, Auditor Certification, by Susan "Sam" Yarnell. The agreement and the contract is on file in the County Clerk's office and the Commission office.
