Convene

Presiding Commissioner John Grubaugh called the meeting of the County Commission to order at 10:00 a.m. on July 17, 2008 at the County Commission Office. Attendance: John Grubaugh, Present: Bill Barnett, Present: Tom Huff, Present. County Clerk, Kay Brown taking the minutes.

10:00 a.m. Dave Woolery, DNR RE: Ozone Program

Those present for the meeting were County Consultant, Jim Bresee, George Van Hoesen, Christian County Health Department, Cindy Bilyeu, Melissa Wagner, Emergency Management Director, Phil Amtower and Donna Osborn of the Christian County Headliner.

The Commission met with Dave Woolery of the Department of Natural Resources to discuss the Ozone Program. Mr. Woolery stated that the EPA has changed the acceptable Ozone level to a lower level for the cities and counties. DNR has set up monitoring stations in response to the EPA directive to identify counties at risk. Greene County is at risk and Christian County is on the edge. The EPA has created a list of standards that the cities and counties must comply with. According to Mr. Woolery, Doug Neidigh, of the Ozark Clean Air Alliance would like to meet with the Christian County, the County Health Department and Ozark and Nixa to create a plan to comply with the new EPA requirements.

Western Commissioner Bill Barnett asked if there will be money available for this mandate.

Mr. Woolery responded that he didn't know of any money to implement this mandate. The down side is that entities that do not comply with the EPA Ozone standards could possibly have restrictions placed upon development. The Commission set a meeting for July 21st at 11:00 a.m. to meet with Mr. Enidgh for more information.


Ordinance - 07-17-08-01 -
