## Resolution - 07-31-08-01 - Vote

American Children's Safety Network

IN THE MATTER OF A RESOLUTION SUPPORTING THE AMERICAN CHILDREN'S SAFETY NETWORK

WHEREAS, every day in the United States Children suffer permanent brain injuries from bicycle accidents, and

WHEREAS, the use of bicycle helmets could relieve the number of deaths caused by accidents, and

WHEREAS, 33% of hospital emergency room visits by children are for treatment of head injuries, and

THEREFORE: The Christian County Commission supports the American Children's Safety Network in their endeavor to recycle outdated license plates to be used to purchase bicycle helmets.

RESOLVED: that an effort be made to develop community support for a bicycle helmet campaign and the campaign include:

1. Establishing a coalition of interested groups,
2. Developing and utilizing materials, handouts, and posters that provide information about the importance of helmet use.
3. Enlisting the assistance of media outlets to promote the safety program of wearing helmets while bicycling.

RESOLVED, that the Christian County Commission hereby adopts this resolution the 31st day of July 2008.
