Convene

Presiding Commissioner John Grubaugh called the meeting of the County Commission to order at 9:00 a.m. on September 8, 2008 at the County Commission Office. Attendance: John Grubaugh, Present: Bill Barnett, Present: Tom Huff, Absent. Chief Deputy Clerk, Norma Ryan taking the minutes.

9:00 Bid Opening for Salt for County Road Districts 1 and 2

The Commission opened bids from Independent Salt Company-no bid, Bingham-78.00 per ton delivered guaranteed through Dec.31, 2008., and North American Salt Co-did not submit a bid at this time. The Commission will accept the Bingham bid and re-bid the first part of December 2008.

Motion/Vote - Accept the Bid for Salt from Bingham

Western Commissioner Bill Barnett made a motion to accept the bid from Bingham Sand and Gravel for salt through December 31, 2008 based on availability. John Grubaugh seconded the motion. The motion passed by vote: John Grubaugh (Yes), Bill Barnett (Yes), Tom Huff (Absent). Should they not be able to provide salt the Commission will seek other sources for the road department needs.

Right-of-Way Warranty Deed for Carter Road -- 9:30 a.m. The Commission approved and signed a Right-of-Way Warranty Deed for Carter Road to transfer additional right-of-way to C1 Road District. The deed was attested to and signed by Chief Deputy Clerk, Norma Ryan. The grantors are Keith and Carolina Humble and Jerry and Debbie Kleen.

9:45 a.m. Planning and Zoning Board of Adjustment Appointments

The Commission interviewed Phil Shelton to fill a possible opening on the Planning and Zoning Board of Adjustments. Bob Massengale has indicated a desire to submit a letter of resignation after many years of service.

10:30 a.m. Asessessor's Office Decision on Scanner/Imaging System

The Commission met with Assessor, Sandra Bryant-Littles for her recommendation for a scanner/imaging system. She prefers the DISC bid but it includes the hot swap and warranty that copy products did not put in their bid. John talked to the salesman for Copy Products and was assured the hot swap and 1 yr. warranty was included. The Commission talked to the representative for Copy Products and was assured that the scanner was covered with a one year warranty, and he agreed, should the need arise, to provide the Assessor's office with a replacement scanner during that period.
