#### Convene

#### 9:00 a.m. Christian County Extension Office -- Budget Discussion

Those present for the meeting were Andy Arndt, County Consultant Jim Bresee and Donna Osborn of the Christian County Headliner News.

The Commission met with Dr. Gordon Carriker of the University of Missouri Extension Office to discuss the 2009 Budget. Dr. Carriker submitted their proposed budget and he reviewed the budget by line items. The Commission will take the budget under advisement.

## 9:45 a.m. Great River Engineering RE: Deer Trail Court and other Christian County Roads

Those present for the meeting were Commission Secretary Julia Maples, County Council John Housley and County Consultant Jim Bresee.

The Commission met with Glenda Hammons, Administrator for Planning and Zoning and Senior Planner Bob Atchley, Steve Brown and Spencer Jones of Great River Engineering to discuss Deer Trail Road and other Christian County Roads. The Commission received correspondence from Michael Downs, a resident on Deer Trail Court. He was inquiring as to why the county had not assumed maintenance on Deer Trail Court. Mr. Jones stated that Elk Valley Road at some point was maintained by the county road department. Spencer Jones and Western Commissioner Bill Barnett, have done research into the matter and to date no record has been found. The Commission will set a meeting at a future date with Mr. Downs and the other residents to find a conclusion to the matter epted by the county. The Commission set a meeting for November 10th for a meeting at 11:00 a.m.

The Commission also met with the Planning and Zoning staff and County Counselor Housley to discuss proper bonding methods and bonding amounts, to insure the county is properly protected and that the infrastucure is put in place for future development.
