9:00 a.m. Bid Opening -- Asphalt

The Commission met with County Auditor Sam Yarnell to discuss the budgets for the tax maintenance fund for Ted Nichols, Family Violence Center, Windridge, and Circuit Judge Orr.

11:07 a.m. County & Municipalites- Southwest Missouri Crime Lab

Those present for the meeting are Commission Secretary Julia Maples, Barb Stillings Alderman for the City of Nixa, Nixa City Alderman, Charles McCorkle, Nixa Police Chief, James Bacon, Ozark City Administrator Steve Childers, Ozark Mayor Watts, County Consultant Jim Bresee and KY3 Television.

The Commission discussed making a contribution to the Southwest Missouri Crime Lab . The Commission sent an email to all the municipalities concerning funding for the Southwest Missouri Crime Lab . Greene County has requested funding partners for this project and the Commission believe that this is a very good decision. Presiding Commissioner Grubaugh emphasized the cost of housing prisoners and that the Crime Lab would reduce the time a prisoner would be housed in the county jail before moving to State prison . Greene County has requested \$ 112, 899.00, over a ten year period which is \$ 11,290.00 per year.

Ozark Mayor Watts was anticipating what the cost for the City of Ozark would be to include in the city 's 2009 budget. Mayor Watts strongly supported the Commission for their pledged support of the crime lab and praised them for taking the leadership on this needed facility.

Nixa Chief of Police James Bacon responded in support of the crime lab that it will assist all municipalities and all law enforcement agencies.

Motion/Vote - Financing Partner for the Southwest Missouri Crime Lab

Western Commissioner Bill Barnett made a motion to partner with Greene County to build the Southwest Missouri Crime Lab. Western Commissioner, Bill Barnett made the motion to pay the first payment of \$ 11,290.00 from the 2009 budget which includes the payment for all the cities and the county.
