9:00 a.m. Croley Insurance -Cox Health Plan Proposal

The Commission met with Aubrey Gray from Cox Health Plans and Trevor Croley to review health insurance options. Mrs. Gray presented a county health insurance proposal for 2009 from Cox Health Plans. The Commission will take her proposal under consideration.

The Commission had a discussion regarding security in the courthouse. Collector Nichols suggested that the East entrance of the courthouse be the only entrance open for security purposes. Commission, the County Clerk, and the County Auditor signed the contract. The County Counselor will sign the contracts later today.

11:00 a.m. Prosecuting Attorney Re: Child Support

Those present for the meeting were Commission Secretary Julia Maples, County Consultant Jim Bresee, Prosecuting Attorney Ron Cleek, and Chris Cluck from the Christian County Headliner.

The Commission met with Ron Cleek and Dennis Tichelkamp to discuss the county 's child support process. Mr. Cleek has contracted with Mr. Tichelkamp of the Greene County child support enforcement and Taney County has also contracted with Greene County. According to Mr. Cleek, Mr. Tichelkamp will take over the child support for Christian County and one of the Prosecutor's clerk's will be working out of the Greene County office and will be paid by Greene County. This arrangement will free up time for the Prosecutor's staff. The Commission supported Mr. Cleek's decision to contract with Greene County for these services.

1:00 p.m. SEMA & AMAC -- Floodplain Maps

Those present for the meeting were Commission Secretary Julia Maples, County Consultant Jim Bresee, County Counselor John Housley, Spencer Jones and Josie Bock of Great River Engineering, Glenda Hammons, Bob Atchley, Donna Baxter of the Springfield Newsleader, Jason Schneider and Dale, Schmutzler with SEMA, Mary Snapp, Valerie Carr, William Matthews, Robert Wilslef, Marcus Heilman, and Joel File AMAC

Spencer Jones and Josie Bock of Great River Engineering presented to the Commission the floodplain maps for the county. Mr. Jones stated that the change from the old maps and the new maps are indicated in red. The floodplain area has increased on the new maps by 7%. There are 2,500 parcels that will be affected by this new floodplain and 155 new structures that were not in the previous floodplain will now be in the flood plain and 134 parcels that were in the old flood plain are no longer in the flood plain. The new floodplain maps will be in effect in eighteen months.
