The Grantor is SCI Investments, Inc. The signers were Keith D. Harris, President and Brent A. Maples, Secretary of SCI Investments. County Clerk, Kay Brown attested to the signing.

The Commission met with Spencer Jones of Great River Engineering to discuss West Deer Trail Court in Timberview Subdivision. Western Commissioner, Bill Barnett called the meeting. The County currently maintains Antler Road and Elk Valley Road but not Deer Trail Court. Mr. Jones researched the minutes and on August 8th, 1988, Antler Road was accepted for county maintenance. However, there is no record where the county began the maintenance of Elk Valley Road. The Commission discussed accepting the road as it is but not to widen the road or making any improvements and the county would need a fifty foot right-of-way. A resident stated that she did a title search when purchasing her property and it does not show

the road as a private road. There were other residents that voiced their concerns how the road is recorded for resale and refinancing purposes.
