The Commission discussed with the officeholders the possibility of hiring a full time Computer Technician . County Auditor Sam Yarnell stated that the county has spent \$70,000.00 from general revenue for computer technician services. The Sheriff and E-911 use different service technicians. Collector Ted Nichols stated that one advantage would be that someone on sight would save the county money or we could use a managed service provider. The Prosecutor uses PC Alliance and to have a different computer technician, they would need to be vastly knowledgeable and the same applies for Sheriff, 911, and the Assessor. Basically this IT person would be someone to keep the system running on a more timely manner . E-911 Director Danny Clinton suggested that for the first 6 months of 2009 that the office holders keep track and meet again in July to decide if it is cost effective. Presiding Commissioner Grubaugh agreed to have all offices keep track and convene in July with the results and recommendations . The Commission will meet with some IT people and see what they suggest .
