9:45 a.m. Office Holders Discussion Security in the Courthouse

Those present for the meeting were Commission Secretary Julia Maples, Treasurer Karen Matthews, Cindi Carey, Collector Ted Nichols and Deputy Cindi Carey, Terri Blevins from Juvenile, Sheriff Elect Joey Kyle, Building Inspections Administrator Sam Proffer, Recorder Roy Meadows, Commission Secretary Cindy Childress, Sheriff Robertson, Security Director Rick Chastain, Assessor Sandra Bryant-Littles, Auditor Sam Yarnell and Donna Osborn of the Christian County Headliner.

Sheriff -Elect Joey Kyle addressed the Commission and the officeholders regarding the security in the courthouse. According to Mr. Kyle, the security analysis shows that the courthouse is wide open. Mr. Kyle introduced Randy Price as the speaker. Mr. Price has 15 years experience in law enforcement and owns a security consulting business. Mr. Price presented the security analysis and offered many suggestions and ideas to improve the courthouse security. Some of his suggestions included: surveillance cameras, using one entrance and exit, code words, the use of a metal detector at the entrance to the building, law enforcement on site and to have an alternate plan of leaving the courthouse. According to Mr. Price, safety and liability is the greatest concern for the county and by taking a proactive approach will mitigate the risk.

Westerm Commissioner Barnett suggested posting security signs on the doors. He also asked how Greene County handles courthouse security?

Presiding Commissioner Grubaugh asked about security for the evening meetings that are held in the courthouse? Rick Chastain stated that the courthouse needs to be secured whenever evening meetings are held.

Collector Nichols stated that having a deputy in his office has changed the atmosphere of the people that come in to pay their taxes.

Building Inspection Administrator, Sam Proffer had concerns because of prior incidents he had encountered at another municipality.
