THIS AGREEMENT, is made and entered into by and between KAY BROWN, County Clerk and Election Authority for Christian County, Missouri, hereinafter referred to as "Christian County" and, DONNA NEELEY, County Clerk and Election Authority for Taney County, Missouri, hereinafter referred to as "Taney County", WITNESSETH:

WHEREAS, this agreement is entered into because the Bradleyville School District, hereinafter referred to as "District" was created and encompasses portions of both Christian and Taney County, and this District has called for an April 5th, 2011, Election for the registered voters of the District, and

WHEREAS, pursuant to RSMo. 115.023.3, when an election authority must conduct an election in an area outside its jurisdiction, and more than one election authority is involved, the law allows all applicable election authorities to enter into an agreement to have all powers and duties necessary, and

WHEREAS, it is the desire of Christian County and Taney County to enter into such agreement to conduct the April 5th, 2011, Election for the Bradleyville School District; and


NOW, THEREFORE, in consideration of the mutual promises, covenants and undertakings expressed herein, the parties hereby agree as follows:



4. Christian County shall provide Taney County with a poll book, which sets out all registered voters in Christian County located in the District, sample ballots and CORAL PINK Official ballots and shall give it to Taney County by the end of business on or before April 1st, 2011;
5. Christian County shall provide Taney County self addressed, postage paid bags to return the poll book and all used ballots, unused ballots and all spoiled and damaged ballots and a certification of the results to Christian County. Christian County shall do the billing to the District, for the notices, ballots, postage and the few supplies needed to conduct the election. Taney County will bill Bradleyville School District for the publication notice and any other expenses incurred.
6. Christian County agrees to cooperate with Taney County to conduct this election, including but not limited to district information, maps, poll books, supplies, addresses, etc., and shall work together with Taney County to complete this election.

The term of this Agreement shall be through the finalization of the April 5th, 2011 Election, which shall include the closing of the election, return of the poll books, used and unused ballots, certification of the election, and all other obligations not specifically set forth that will finalize this April 5th, 2011 Election.

WHEREAS, it is the desire of Christian County and Webster County to enter into such agreement to conduct the April 5th, 2011, Election for the Fordland R-III School District; and

4. Christian County shall provide Webster County with a poll book, which sets out all registered voters in Christian County located in the District, sample ballots and YELLOW Official ballots and shall give it to Webster County by the end of business on or before April 1st, 2011;
5. Christian County shall provide Webster County self addressed, postage paid bags to return the poll book and all used ballots, unused ballots and all spoiled and damaged ballots and a certification of the results to Christian County. Christian County shall do the billing to the District, for the notices that were mailed, ballots, postage and the few supplies needed to conduct the election. Webster County will bill Fordland School District for the publication notice and any other expenses incurred.
6. Christian County agrees to cooperate with Webster County to conduct this election, including but not limited to district information, maps, poll books, supplies, addresses, etc., and shall work together with Webster County to complete this election.

The term of this Agreement shall be through the finalization of the April 5th, 2011 Election, which shall include the closing of the election, return of the poll books, used and unused ballots, certification of the election, and all other obligations not specifically set forth that will finalize this April 5th, 2011 Election.
