



PETITION FOR REMOVAL OF CANDIDATE

COMES NOW Plaintiff, Laura Johnson, pro se, and for her Petition for Removal states as follows:

1. Plaintiff is currently a candidate for the office of Associate Circuit Judge, Division 2 in the primary election scheduled for August 5, 2014.
2. Defendant is the Christian County Clerk and election authority for Christian County.
3. Plaintiff desires to withdraw her candidacy immediately.
4. Pursuant to § 115.359, RSMo., Plaintiff is precluded from withdrawing without an Order of this Court, however, is eligible to withdraw by court Order because the primary election is more than six weeks away at this time. (115.359, RSMo., ¶ 2).
5. Plaintiff believes that there will be no additional costs to the County if she withdraws immediately.

WHEREFORE, Plaintiff prays for the Court for its Order (1) allowing Plaintiff to withdraw her candidacy for Associate Circuit Judge, Division 2 of Christian County; (2) ordering Defendant in her official capacity only, to remove her name from the ballot for the primary election on August 5, 2014; and (3) for such other relief as is just.
