ELECTION AUTHORITY INTERGOVERNMENTAL AGREEMENT

THIS AGREEMENT, is made and entered into by and between KAY BROWN, County Clerk and Election Authority for Christian County, Missouri, hereinafter referred to as "Christian County" and DONNA NEELEY, County Clerk and Election Authority for Taney County, Missouri, hereinafter referred to as "Taney County", WITNESSETH:

WHEREAS, this agreement is entered into because the Spokane R-VII School District, hereinafter referred to as "District" was created and encompasses portions of both Christian and Taney County, and this District has called for an August 5, 2003, Election for the registered voters of the District, and

WHEREAS, pursuant to RSMo. 115.023.3, when an election authority must conduct an election in an area outside its jurisdiction, and more than one election authority is involved, the law allows all applicable election authorities to enter into an agreement to have all powers and duties necessary, and

WHEREAS, it is the desire of Christian County and Taney County to enter into such agreement to conduct the August 5, 2003 Election for the Spokane R-VII School District; and

NOW, THEREFORE, in consideration of the mutual promises, covenants and undertakings expressed herein, the parties hereby agree as follows:

- 1. Christian County will conduct the election for the entire Spokane School District and staff all precincts necessary for Taney County, except Absentee Voting which shall be handled separately by each County;
- 2. Christian County will handle all publications and programming/election equipment costs including supplies;
- Christian County will provide Taney County supplies for conducting Absentee Voting for Taney County voters, including Sample Ballots and Taney County shall keep an accurate record of Absentees and give them to Christian County at the end of business on August 5, 2003;
- 4. Taney County shall provide Christian County with a poll book which sets out all registered voters in Taney County located in the District, and shall give it to Christian County at the end of business on August 2, 2003;
- 5. Taney County shall provide Christian County with an itemized list of any election costs and Christian County shall do all billing to the District, including but not limited to estimated costs and final costs, and shall pay to Taney County their election costs;
- 6. Christian County agrees to cooperate with Taney County to conduct this election, including but not limited to district information, maps, poll books, supplies, addresses, etc., and shall work together with Taney County to complete this election;
- 7. Taney County agrees to cooperate with Christian County to conduct this election, including but not limited to district information, maps, poll books, supplies, addresses, etc., and shall work together with Christian County to complete this election;

The term of this Agreement shall be through the finalization of the August 5th, 2003 Election, which shall include the closing of the election, return of the poll books, scanning of voter credits, certification of unused ballots, and all other obligations not specifically set forth that will finalize this August 5th, 2003 Election.

This agreement contains the entire agreement between the parties herein and may be modified by the consent of both parties.

ELECTION AUTHORITY INTERGOVERNMENTAL AGREEMENT

THIS AGREEMENT, is made and entered into by and between KAY BROWN, County Clerk and Election Authority for Christian County, Missouri, hereinafter referred to as "Christian County" and, JUDY BERKSTRESSER, County Clerk and Election Authority for Stone County, Missouri, hereinafter referred to as "Stone County", WITNESSETH:

WHEREAS, this agreement is entered into because the Spokane R-VII School District, hereinafter referred to as "District" was created and encompasses portions of both Christian and Stone County, and this District has called for an August 5, 2003, Election for the registered voters of the District, and

WHEREAS, pursuant to RSMo. 115.023.3, when an election authority must conduct an election in an area outside its jurisdiction, and more than one election authority is involved, the law allows all applicable election authorities to enter into an agreement to have all powers and duties necessary, and

WHEREAS, it is the desire of Christian County and Stone County to enter into such agreement to conduct the August 5, 2003 Election for the Spokane R-VII School District; and

NOW, THEREFORE, in consideration of the mutual promises, covenants and undertakings expressed herein, the parties hereby agree as follows:

- Christian County will conduct the election for the entire Spokane School District and staff all precincts necessary for Stone County, except Absentee Voting which shall be handled separately by each County;
- 2. Christian County will handle all publications and programming/election equipment costs including supplies;
- Christian County will provide Stone County supplies for conducting Absentee Voting for Stone County voters, including Sample Ballots and Stone County shall keep an accurate record of Absentees and give them to Christian County at the end of business on August 5, 2003;
- 4. Stone County shall provide Christian County with a poll book which sets out all registered voters in Stone County located in the District, and shall give it to Christian County at the end of business on August 2, 2003;
- Stone County shall provide Christian County with an itemized list of any election costs and Christian County shall do all billing to the District, including but not limited to estimated costs and final costs, and shall pay to Stone County their election costs;
- Christian County agrees to cooperate with Stone County to conduct this election, including but not limited to district information, maps, poll books, supplies, addresses, etc., and shall work together with Stone County to complete this election;
- 7. Stone County agrees to cooperate with Christian County to conduct this election, including but not limited to district information, maps, poll books, supplies, addresses, etc., and shall work together with Christian County to complete this election;

The term of this Agreement shall be through the finalization of the August 5th, 2003 Election, which shall include the closing of the election, return of the poll books, scanning of voter credits, certification of unused ballots, and all other obligations not specifically set forth that will finalize this August 5th, 2003 Election.

This agreement contains the entire agreement between the parties herein and may be modified by the consent of both parties.
