ORDINANCE NO. 04-028

AN ORDINANCE CALLING AN ELECTION IN THE CITY OF OZARK,
MISSOURI

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF
OZARK, MISSOURI, AS FOLLOWS:

Section 1. The Board of Aldermen finds it necessary and hereby declares its intent to include the City of Ozark in the Ozark Rural Fire Protection District's Boundaries for the purpose of fire protection only.

Section 2. An election is hereby ordered to be held in the City of Ozark, Missouri, on August 3, 2004, on the following question.



The City Clerk is hereby authorized and directed to notify the County Clerk of Christian County, Missouri, of the adoption of this Ordinance no later than 5:00 P.M. on May 25, 2004 and to include in said notification all of the terms and provisions required by the Comprehensive Election Act, Chapter 115 of the Revised Statutes of Missouri, as amended.

Section 5. This Ordinance shall be in full force and effect from and after its passage and approval.
