
CITY OF HIGHLANDVILLE

CITY OF SPARTA

Shall the City of Sparta, Missouri, issue its combined waterworks and sewerage system revenue bonds in an amount not to exceed \$2,000,000 for the purpose of acquiring, constructing, improving or extending the combined waterworks and sewerage system, including, but not limited to, the construction of improvements and extensions to the existing waterworks storage and distribution system and all related appurtenances with the acquisition of needed equipment and rights-of-way for the improvements and extensions, and any necessary sidewalk, street and storm drainage repairs resulting from the improvements and extensions to the combined waterworks and sewerage system, with the cost of operation and maintenance of said combined waterworks and sewerage system and the principal of and interest on said revenue bonds to be payable solely from the revenues derived by the City from the operation of its combined waterworks and sewerage system, including all future improvements and extensions thereto?

The authorization of such revenue bonds will authorize the collection of rates, fees and charges for the use of and services provided by the improvement, extension and equipping of the City's combined waterworks and sewerage system sufficient to pay the costs of operating and maintaining the combined waterworks and sewerage system, to pay the principal of and interest on said revenue bonds as they fall due, and to provide for and maintain all contractual obligations incurred during the issuance of said revenue bonds.
