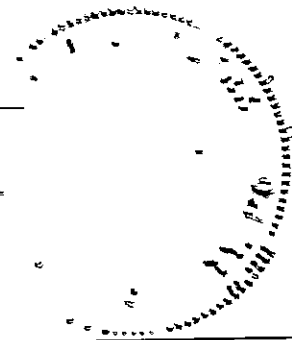

ORDINANCE: # 3B

AN ORDINANCE

CALLING FOR A SPECIAL ELECTION IN THE CITY OF HIGHLANDVILLE, MISSOURI (THE CITY) TO BE HELD ON TUESDAY NOVEMBER 8, 2005, IN SAID CITY FOR THE PURPOSE OF TESTING THE SENSE OF THE QUALIFIED VOTERS OF SAID CITY ON A PROPOSITION TO LEVY A PROPERTY TAX WITH A RATE NOT TO EXCEED \$.71 PER \$100 OF ASSESSED VALUATION AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HIGHLANDVILLE, MISSOURI as follows.

Section 1. A special election be and the same is hereby called and ordered to be held in the City of Highlandville, Missouri (the "City"), on Tuesday November 8, 2005, for the purpose of testing the sense of the qualified voters of said City upon the following proposition:

Shall the City of Highlandville, Missouri, levy a property tax for municipal purposes with a rate not to exceed \$.71 per \$100 of assessed valuation.

The authorization of said tax will authorize the levy and collection of an annual Tax in addition to the other taxes provided for by law on all taxable tangible Property in said City.

Section 2. The City Clerk is hereby authorized and directed to notify the County Clerk of Christian County, Missouri, of the adoption of this Ordinance no later than 5:00 p.m. on the tenth Tuesday prior to the date of the election, and to include in said notification all of the terms and provisions required by Chapter 115 RSMo., as amended.

Section 3. Said election shall be held in the several wards and precincts of the City, as the same are now defined by the ordinances of the City, in voting places as shall be established therein by the City Clerk or the County Clerk as required by Chapter 115 RSMo., as amended, and the polls shall be open on said election day during the hours as provided by law.

Section 4. The County Clerk of Christian County, Missouri, shall appoint the judges and clerks of said election and shall conduct the election and make returns to the Board of Aldermen of the City as provided by the laws of the State of Missouri, and the Ordinances of the City applicable to other municipal elections. The City Clerk or the County Clerk is hereby authorized to do all things necessary to comply with the provisions of State Law and City ordinances pertaining to conduct of elections.

Section 5. The County Clerk of Christian County, Missouri, is hereby authorized and directed to conduct such election in a manner consistent with the provisions of Chapter 115 RSMo., as amended.

Section 6. The form of the notice of election for said special election, a copy of which is attached hereto and incorporated herein by reference, is hereby approved.

Section 7. All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed insofar as they are in conflict. Any provision of this ordinance in conflict with Chapter 115 RSMo., as amended, shall be null and void and shall be superceded. Appropriate public officials are hereby authorized to take any and all actions to comply with Chapter 115 RSMo., as amended

Section 8. The Board of Aldermen of the City finds and declares that this Ordinance constitutes an emergency because it pertains to calling an election. Therefore, this Ordinance shall be in full force and effect from and after passage and approval.

PASSED AND APPROVED at a regular meeting of the Board of Aldermen of the City of Highlandville, Missouri, this 16th day of August, 2005.

AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS OF THE CITY OF HIGHLANDVILLE, MISSOURI, THE PROPOSITION TO AUTHORIZE THE BOARD OF ALDERMEN TO LEVY A PROPERTY TAX RATE OF NOT MORE THAN \$.71 (SEVENTY-ONE CENTS) PER \$100.00 (ONE HUNDRED DOLLARS) ASSESSED VALUATION.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HIGHLANDVILLE, MISSOURI, as follows:

1. That at the regular municipal election on Tuesday, November 8, 2005, the following proposition shall be submitted to the qualified voters of the City of Highlandville, Missouri, to wit:

Shall the Board of Aldermen of the City of Highlandville, Missouri be authorized to levy a property tax rate of not more than \$.71 (seventy-one cents) per \$100.00 (one hundred dollars) assessed valuation?

2. That the ballot to be used at said election shall be in substantially the following form:

Shall the Board of Aldermen of the City of Highlandville, Missouri be Authorized to levy a property tax rate of not more than \$.71 (seventy-one cents) per \$100.00 (one hundred dollars) assessed valuation.
