QUESTION

Shall the Board of Trustees of the Junior College District of Central Southwest Missouri (also known as Ozarks Technical Community College) be authorized to increase the operating tax levy ceiling of the District to \$0.1812 per \$ 100 of assessed valuation for the 2008 calendar year, to \$0.2212 per \$100 of assessed valuation for the 2009 calendar year and to \$0.2612 per \$100 of assessed valuation for the 2010 calendar year for the purpose of paying operating costs of the District, including expanded allied health programs, technical programs and workforce development initiatives?

If this question is approved, the operating levy of the District will increase by \$0.04 per one hundred dollars of assessed valuation in each of the three calendar years 2008 through 2010 resulting in a total increase of \$0.12 per one hundred dollars of assessed valuation over the current estimated operating tax levy of \$0.1412 per one hundred dollars of assessed valuation.

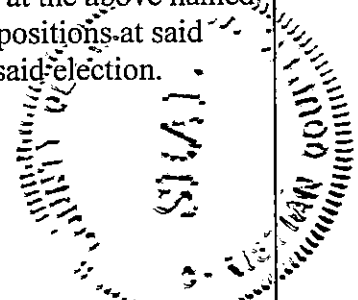
