Shall Chadwick R-1 School District of Christian County, Missouri, incur indebtedness
and issue its general obligation bonds in the amount of \$ 570,000 for the purpose of
construction new and improving existing school facilities and furnishing and equipping
the same, enabling the District to qualify for any available federal or state matching funds
therefor? If this proposition is approved, the adjusted tax levy is estimated to remain the
same at \$ 1.0876 per one hundred of assessed valuation.

The authorization of said bonds will authorize the levy and collection of an annual tax in
addition to all other taxes provided for by law on all taxable tangible property in said
School District sufficient to pay the principal of and interest on said bonds as they fall
due and to retire the same within twenty (20) years from the date thereof.

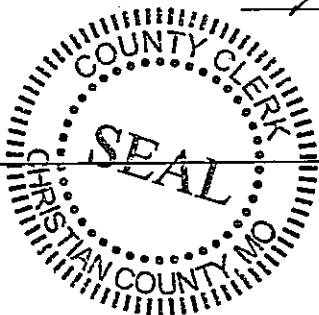

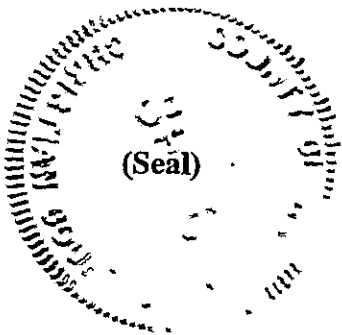

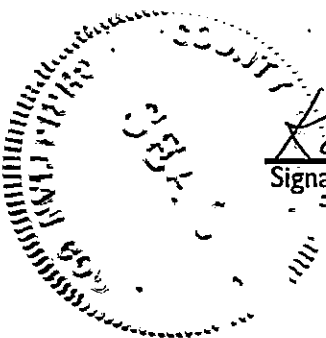
