





I, Kay Brown, Christian County Clerk, do hereby certify the following election results of the Special election held in Christian County, Missouri, on November 2, 2010.

#### CHADWICK R-1 SCHOOL DISTRICT

Shall the Chadwick R-1 School District of Christian County, Missouri, incur indebtedness and issue its general obligation bonds in the amount \$ 350,000 for the purpose of acquiring equipment leased by the district, constructing a new and improving existing school facilities, furnishing and equipping the same, and purchasing one school bus. If this proposition is approved, the adjusted tax levy is estimated to remain the same at \$ 1.0497 per one hundred of assessed valuation.

365 YES 60.23% 241 NO 39.77%

The bond issue surpassed the 57.14% majority.
