Shall the City of Sparta, Missouri, issue and sell combined waterworks and sewerage system revenue bonds of the City of Sparta, Missouri, in an amount not to exceed Two Million, Five Hundred Thousand Dollars (\$2,500,000) for the purpose of paying all or a part of the costs of constructing, equipping and acquiring improvements, extensions and replacements for the combined waterworks and sewerage system of said City, including the acquisition of any necessary rights-of-way, with the cost of operation and maintenance of the combined waterworks and sewerage system and repayment of the principal of and the interest on the combined waterworks and sewerage system revenue bonds to be payable solely from the revenue and receipts derived and to be derived from the operation of the combined waterworks and sewerage system, and all future expansions and extensions thereof?

The authorization of such revenue bonds will authorize the collection of rates, fees and charges for the use of and services provided by the construction, equipping and acquisition of improvements, extensions and replacements for the City's existing combined waterworks and sewerage system sufficient to pay the costs of operating and maintaining the combined waterworks and sewerage system, to pay the principal of and interest on said revenue bonds as they fall due, and to provide for and maintain all contractual obligations incurred during the issuance of said revenue bonds.
