# APPLICATION FOR ORDER PERMITTING LATE NOTIFICATION TO ELECTION AUTHORITY PURSUANT TO SECTION 115.125.2, RSMo.

COMES NOW Petitioner Chadwick Rural Volunteer Fire Protection District, by and through its undersigned counsel, and for its Application for Order Permitting Late Notification to Election Authority Pursuant to Section 115.125.2, RSMo., states as follows:

- 1. Petitioner is a rural volunteer fire protection district located in Christian County, Missouri, formed pursuant to and existing by virtue of Chapter 321, RSMo., and governed by its duly elected board of directors.
- 2. Respondent is the election authority in and for Christian County, Missouri, with the responsibility for conducting the election hereinafter mentioned.
- 3. By duly enacted resolution, Petitioner's board of directors authorized the following question to be placed on the ballot for the election to be held on August 4, 2015:

Shall the board of directors of the Chadwick Rural Volunteer Fire Protection District be authorized to levy an additional tax of not more than twenty-five cents on the one hundred dollars assessed valuation to provide funds for the support of the district?"

- 4. Section 115.125.1, RSMo., provides that "[n]ot later than 5:00 p.m. on the tenth Tuesday prior to any election...the officer or agency calling the election shall notify the election authorities responsible for conducting the election" of "the name of the officer or agency calling the election," and "shall include a certified copy of the legal notice to be published pursuant to subsection 2 of section 115.127."
- 5. Due to the need for revision of ballot language previously submitted to Respondent for placement on the August 4, 2015 ballot, Petitioner was unable to meet the aforesaid deadline for notifying Respondent of the proposed ballot question.
  - 6. Section 115.125.2, RSMo., provides:
    - 2. Except as provided for in sections
    - 1. 115.247 and 115.359, if there is no additional cost for the printing or reprinting of ballots or if the political subdivision or special district calling for the election agrees to pay any printing or reprinting costs, a political subdivision or special district may, at any time after certification required in subsection 1 of this section, but no later than 5:00 p.m. on the sixth Tuesday before the election, be permitted to make late notification to the election authority pursuant to court order, which, except for good cause shown by the election authority in opposition thereto, shall be freely given upon application by the political subdivision or special district to the circuit court of the area of such subdivision or district. No court shall have the authority to order an individual or issue be placed on the ballot less than six weeks before the date of the election, except as provided in sections 115.361 and 115.379.
  - 7. Petitioner states that the president of its board of directors has consulted with

Respondent, who has confirmed that there will be no additional cost for the printing or reprinting of ballots, and, further, that Respondent is not opposed to Petitioner making the late notification permitted by Section 115.125.2, RSMo.

WHEREFORE, Petitioner Chadwick Rural Volunteer Fire Protection District moves the Court for an order permitting it to make late notification to Respondent Kay Brown, County Clerk in and for Christian County, Missouri, in order that Petitioner's aforesaid ballot question may be placed on the ballot for the August 4, 2015 election to be conducted by Respondent, and for such other and further relief as the Court deems just and proper in the premises.
