
A vote in favor of the question will not serve to raise existing sales tax rates imposed by the City of Republic.

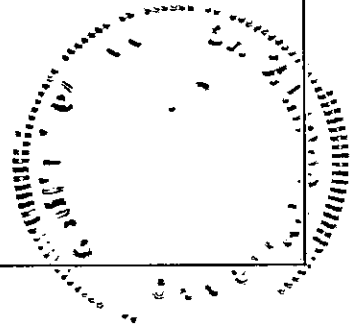

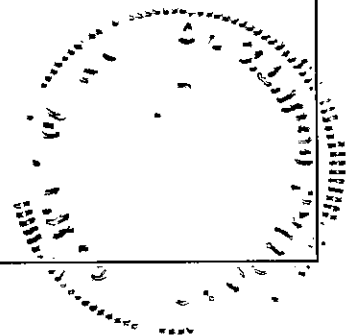

CLEVER R-V SCHOOL DISTRICT PROPOSITION K.I.D.S.


Shall the Board of Education of the Clever R-V School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of One Million One Hundred Twenty Five Thousand Dollars (\$1,125,000) for the purpose of providing funds to construct, equip and furnish a new early childhood center; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1.0300 per one hundred dollars of assessed valuation of real and personal property.

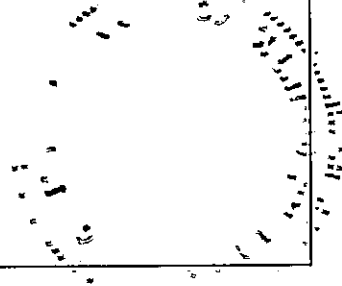

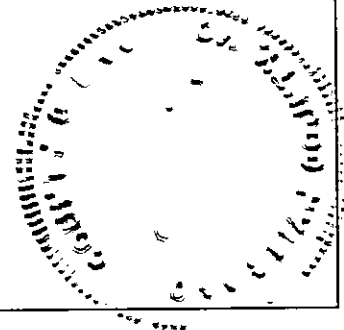

**CITY OF HIGHLANDVILLE
PROPOSITION 1**

Shall the City of Highlandville impose a local use tax at the same rate as the total local sales tax rate, currently One and one half percent (1 ½%), provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action? A use tax return shall not be required to be filed by persons whose purchases from out of state vendors do not in total exceed two thousand dollars in any calendar year.

Shall the City of Highlandville discontinue applying and collecting the local sales tax on the titling of motor vehicles, trailers, boats, and outboard motors that were purchased from a source other than a licensed Missouri dealer?


