NOTIFICATION OF RECOUNT Pursuant to Section 115,601,3, RSMo.

THE MISSOURI SECRETARY OF STATE,

To all the Election Authorities, State of Missouri:

WHEREAS, I have been duly notified that the results of the Primary Election August 5, 2008, for the Democratic Party nomination for the Office of Attorney General, established the defeat of one candidate by less than one percent of the votes cast; and

WHEREAS, I have been requested by Margaret Donnelly, the candidate who received the second highest number of votes and was defeated by less than one percent of the votes cast, to hold a recount of the votes in the race for Attorney General pursuant to Section 115.601, RSMo.

NOW THEREFORE, I, ROBIN CARNAHAN, SECRETARY OF STATE OF MISSOURI, do hereby issue this Notification of Recount to all Missouri Election Authorities and further authorize the Election Authorities to recount the ballots cast in their jurisdictions during the August 5, 2008 Primary Election for the Democratic nomination for the office of Attorney General. The recount of ballots in each jurisdiction shall be conducted according to procedures directed by the Secretary of State. Election Authorities shall certify and deliver results of this recount to the Secretary of State's Office on or before September 9, 2008.
