On Tuesday, May 13, 2014, a recount was performed for the Nixa City Bond Election beginning at 9:00 a.m. and ending at 1:00 p.m. The recount was held in the Christian County Clerk's Office, conducted by sixteen disinterested registered voters that represented the City of Nixa. The City of Nixa needed a 57.14% majority for the bond election to pass but received fifty seven percent.
