AN ORDINANCE

AN ORDINANCE CALLING FOR A SPECIAL CITY ELECTION IN THE CITY OF CLEVER, MISSOURI, FOR THE PURPOSE OF HAVING THE QUALIFIED VOTERS OF SAID CITY, ELECT ONE ALDERMEN FOR THE CITY EAST WARD TWO (2) YEAR TERM, DESIGNATION OF A TIME HOLDING SAID ELECTION, PRESCRIBED THE FORM OF BALLOT TO BE USED THEREAT, AND AUTHORIZING THE CITY CLERK TO GIVE SUCH PRESCRIBED INFORMATION AND NOTICE OF SAID ELECTION TO THE COUNTY CLERK OF CHRISTIAN COUNTY.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF CLEVER, MISSOURI AS FOLLOWS:

Section 1. The Special Election shall be held on May 3, 2005 as provided by Missouri Revised Statues with the polling places, judges and clerks, as may be provided by the county clerk, as the same is now set forth by the Missouri Revised Statutes, as needed.

Section 2. At the said Special Election the following offices shall be on the ballot and filled by the election for a term of office as stated below:

One Aldermen for East Ward 2 (two) year term

Section 3. That the City Clerk of the City of Clever, Missouri, be and she is, hereby authorized and directed to give notice of said Special Election to the County Clerk of Christian County, who will be responsible for causing the same to be published in some newspaper of general circulation, a notice of time, place of holding and purpose of said Special Election. The County Clerk will determine dates of said notices to be published in accordance with the requirements of the Missouri Revised Statutes. Said Special Election shall be held and conducted and the results thereof shall be canvassed in all respects in conformity with the Constitution and laws of the state of Missouri and accordance with all ordinances adopted by the Board of Alderman of the City of Clever, Missouri.

Section 4. That the ballets to be used at Special Election shall be in substantially the following form with instructions to the voters for the type of ballot chosen to be used by the County Clerk;

Alderman East Ward For a term of two (2) years

Section 5. That the County Clerk is hereby designated as the Special Election authority for the administration of the Special Election as his duties are defined and set forth in the Missouri Revised Statues as amended and that the County Clerk is hereby authorized and directed to prepare and cause to be printed, ballots as herein provided, and to prepare or procure the necessary voter registration books, and Special Election forms and supplies, and shall cause the same to be delivered to the judge of said Special Election.

Section 6. That this ordinance shall be full force and effect from and after its passage and approval.

Read two (2) times and PASSED by the Board of Alderman of the City of Clever, Missouri, this 11th day of April, 2005.
