Goal 1: Protect the lives and livelihoods of all citizens.

Objective 1.1: *Promote education, outreach, research and development programs to improve public awareness of natural hazards and hazard mitigation alternatives that can reduce vulnerabilities.*

Action: Encourage the newspapers to publish information on hazards and ways to reduce vulnerabilities.

Action: Expand and improve the County's Emergency Communications Network by keeping the reverse 911 database and maps up to date and implementing and maintaining alert messaging technologies, such as; IRIS or others as they become available to alert civil employees and the public of natural hazard events.

Action: Add warnings and markers at all low water crossings in the county.

Action: Maintain programs enabling the distribution of low-cost NOAA all-hazard radios for continuous operation in homes, businesses and all facilities for public accommodation.

Objective 1.3: *Provide for safe shelter during weather extremes.*

Objective 2.2: *Ensure that future development in the county is as "hazard proof" as possible.*

Action: Ensure that new dams are constructed in compliance with the national dam safety hazard reduction initiative.

Goal 3: Ensure and enhance continued operation of government and emergency functions in a disaster.

Objective 3.1: Strengthen communication and coordinate participation between public agencies, citizens, non-profit organizations, business, and industry to create a widespread interest in mitigation.

Action: Identify, review and implement mechanisms to foster collaboration among jurisdictions, agencies and special districts.

Action: Encourage all agencies to adopt and sign mutual aid agreements

Action: Increase communication, coordination, and collaboration between wildland urban interface property owners, firefighters and officials to address risk, existing mitigation measures, and federal assistance programs.

Action: Develop public and private partnerships to implement mitigation actions.
