

PETITION TO VOTE ON READOPTION OF SPECIAL  
ROAD DISTRICT, KNOWN AS OZARK \*SPECIAL ROAD DIST

We, the undersigned qualified voters and taxpayers residents of the Ozark Special Road District of Christian County, Missouri, do hereby respectfully petition the Honorable County Court of Christian County Missouri to resubmit the ~~adoption~~ proposition of the adoption of Article Ten Chapter 151 of the Revised Statutes of the State of Missouri passed and approved by the State Legislature <sup>of Missouri</sup> March 9, 1895, relating to Special Road districts. That the said special road district is described as follows, to wit; Commencing at the NW Corner of Section 32 Township 28 Range 21, thence South to the SW Corner of Section 32 Township 27 Range 21, thence East to the SE Corner of Section 36 township 27 Range 21, thence North to the NE Corner of Section 36 Township 28 Range 21 and thence West to the NW Corner of Section 32 Township 28 Range 21 to point of beginning. Containing in all 35 square miles more or less. And known as Ozark Special Road District. That the said proposition be <sup>to be voted upon by the qualified voters of said Special</sup> submitted at the next General Election to be holden in said Special Road District in Christian County and State of Missouri to be holden at the various precincts thereof, on the 8th day of November 1910.
