AN ORDER RELATING TO
SPECIAL ROAD DISTRICT EXTENSION

BE IT ORDAINED by the County Court of Christian County that:

On the 18th day of April, 1969, a petition for extension of Special Road district signed by at least fifty per cent of the property owners of the following described real estate, to-wit: All in Christian County, Missouri,

All of that part of Section Eighteen (18) lying South of Finley River;
All of Section Nineteen (19) and Section Thirty (30); all in Twp.
Twenty seven (27), Range Twenty (20), Christian County, Missouri;

and a second petition for extension of special road district signed by at least thirty five inhabitants of the OZARK SPECIAL ROAD DISTRICT OF CHRISTIAN COUNTY were filed with the County Court of Christian County, calling for a special election extending the territory of the above said special road district to include the above described real estate.

That said petitioners pray for a special election to vote upon the proposition of extension within the statutory period after notice by publication to the voters and inhabitants of said special road district;


WHEREFORE, it is ordered that the County Clerk of Christian County proceed with notice of said election to be held on the 2nd day of May, 1969, after two weeks of consecutive publication in a legal newspaper of general circulation; the publication dates being on the 24th day of April, 1969, and again on the 1st day of May, 1969.

WHEREFORE, the proposition to be voted upon is whether the OZARK SPECIAL ROAD DISTRICT OF CHRISTIAN COUNTY should be extended to include the following described real estate, to-wit:

All of that part of Section Eighteen lying South of Finley River;
All of Section Nineteen, and Section Thirty; all in Twp. 27, Range
20, Christian County, Missouri.

The polling place shall be at the Ozark Special Road District Maintenance Shop, located at the intersection of North 3rd Street and East McCracken Road, Ozark, Missouri.
