ORDER CREATING FIRE PROTECTION DISTRICT

A hearing on the Petition for the Organization of the Highlandville Rural Fire Protection District was, after due notice, held before this court on the 7th day of June, 1993 The petitioner appeared by attorney, J. T. Magness. The Court having heard the evidence of said petitioner, it is found that a petition for the organization of said district has been signed and presented to the court in conformity with the provisions of Chapter 321 of the Missouri Revised Statutes; that the allegations of said Petition are true; That notice was published in the local newspaper prior to hearing date.

It is therefore Ordered and declared that this Court has jurisdiction of this proceeding to create the Highlandville Rural Fire Protection District; that said fire protection district is hereby organized and that it shall bear the name of the Highlandville Rural Fire Protection District; and that the boundaries of said fire protection district shall be as follows:

CHRISTIAN COUNTY:

Beginning at the intersection of the Finley River and the Stone/Christian County line thence NE direction of the Finley River to the North Section line of R22WT26N Section 1 thence East to the NE corner Section 6 R21WT26N then south to the SE corner Section 6 thence east to the NE corner of NW 1/4 of NE 1/4 thence south to the SE corner of NW 1/4 of SE 1/4 thence west to SW corner of Section 8, T26NR21W thence South to the SW corner of NW 1/4 of NE 1/4 thence EAST to SW corner of NE 1/4 of NE 1/4 thence south to the SE corner of SW 1/4 of NE 1/4 thence west to SW corner of SW 1/4 thence south to Section line in Section 17 T26NR21W thence East to the NE corner Section 21 thence south to SE corner Section 33 thence East to NE corner Section 3 T25NR21W thence south to SE corner Section 18 T25NR21W thence east to NE corner Section 24 thence south to SE corner Section 36 thence west along county line to Stone County Line thence North along County Line to point of beginning, all being within the Spokane School District.

STONE COUNTY:

All of Ponce de Leon and McKinley Township those Sections of East Washington Township east of James River to include that part of Section 13 R23W T24N with the South boundary to follow the south Section line of Section 13, 18, 17, and 16.; that part of Cass Township east of James River Section 17 and that part of Section 16 both R22WT26W excepting the NE 1/4 of NW 1/4 the NW 1/4 and NE 1/4 of NE 1/4 of Section 16.

This decree of incorporation shall not be final and conclusive until the question of incorporation has been submitted to an election of the voters residing within the boundaries of the fire protection district described above, and until it has been assented to by a majority vote of the voters of the district voting on the question. Submission of the question to the voters shall be held on the 3rd day of August, 1993, and shall be submitted in the form which follows. In addition, on said date, the voters shall vote on the selection of 5 persons to act as the first board of directors of the fire protection district. That the candidates of said proposed fire protection district shall have until 8th, June, 1993 at p.m., to declare their candidacy. June 8, 1993 is the date of final certification to meet the requirements for the August 3, 1992 election. (RSMo. 115.128)

The form of the ballot to be used at said election shall be as follows:

OFFICIAL BALLOT

Instructions to Voters:

Place a cross mark in the square opposite the name of the candidate or candidates you favor. Five directors are to be elected, the one receiving the highest number of votes shall hold office for a term of six years, the persons receiving the second and third highest numbers of votes shall hold office for a term of four years, and the persons receiving the fourth and fifth highest numbers of votes shall hold office for a term of two years and until their successors are duly elected and qualified.
